

Description of Project:

A/E Request for Qualifications for an Advanced Manufacturing Training Center to be located on HGTC Conway Campus. There will be a single building design with the option to use this building design with a separate site work package for another campus in the future when and if funding and approval are obtained. The building will be a one-story, pre-engineered metal building approximately 25 – 30,000 sf. The building will house welding, machine tool, CNC, robotics and mechatronics classrooms/labs. Experience in the design of similar advanced manufacturing training center is an important factor and will be significantly weighted in the selection of the A/E team. The award of Phase I for this project will not be completed until the approval of the B&CB.
