5B. Fall Tuition Increase:

Mr. Hawley brought forth for approval a request to increase fall tuition by 3% for in-state (incounty) students. The tuition cost per credit hour for in-state (in-county) students will increase by \$5 from \$166 to \$171. Motion by Mr. Hucks, seconded by Mr. Helms and carried that the Area Commission approves a fall tuition increase of 3.0% as allowed by HEPI (2019 HEPI is 2.8%). For in-state (in-county) students, the fall tuition cost per credit hour will increase by \$5 from \$166 to \$171.

- Ms. Heafner announced the Office of Institutional Planning, Research and Grants received a Duke Energy Grant for Electrical Lineman and now working on a Duke Energy Grant for Cybersecurity.
- Mr. Mitchell announced the Workforce Development and Continuing Education Division will be offering Youth Summer and STEM Camps. Horry Telephone, Inc. donated \$30,000 to fund scholarships for the camps.
- Ms. Roper announced a mass promotional mailer went out to Horry and Georgetown County residents. Ms. Bonnoitt reported the Addiction and Recovery Series received lots of media coverage.
- Ms. Snyder announced the launch of a new employee recognition program.
- Dr. Wilbanks reported the Culinary Arts Technology Study Abroad students traveled to Paris. The Office of Academic Affairs launched the Academic Affairs Update Newsletter.
