4B. Academic Affairs Curriculum Changes:

5A. Capital Projects and Major Renovations Update:

President Fore and Mr. Hawley gave an update on the following construction and renovation projects:

- Extending the Highway 17 southbound turning lane into Campus and expanding the northbound acceleration lanes from Campus onto Highway 17.
- Renovating Grand Strand Campus Buildings 100, 200, 300 and Campus Infrastructure; renovated Building 200 Interior.

5B. HGTC Accountability Report:

Ms. Heafner discussed the annual accountability report. All State Institutions are required to submit an annual accountability report to the Office of State Budget and Control Board. The South Carolina Technical College System compiles all reports for the Technical Colleges and submits one report for the System. The Accountability Report includes the Mission and Vision and outcomes for the year.

5C. Enrollment Report:

Dr. Batten reported the Fall Overall Headcount is 6740 and the Summer Overall FTE is 4578.1. Students enrolled in Online/Hybrid courses exclusively is 1232.

5D. Legislative Priorities:

President Fore shared the Technical College System 2020-21 budget priorities that included \$28 million (recurring) for base funding for local colleges, \$18 million (non-recurring) for equipment for high demand job skills training, \$51.1 million for lottery tuition assistance (LTAP), \$20 million (non-recurring) for maintenance and repair projects, and additional ongoing initiatives. President Fore asked Area Commission to share this document with the Legislators.

6A. President's Report:

President Fore's report stands as written. Additionally she announced the Myrtle Beach Air Force Base Redevelopment Authority approve the allocation of \$1.5 million over five years to provide funding for equipment for our allied health programs and additional IT upgrades on the Grand Strand Campus. Also, the National Center for Health Statistics, Centers for Disease Control and Prevention, US. Department of Health and Human Services is conducting a major study of the health of persons living in the United States. Horry County has been selected as one of the survey locations and the survey will be conducted from December 20, 2019 thought March 12, 2020. Horry-Georgetown Technical College has been asked to provide space for their Mobile Examination Center (MEC) which consists of four specially designed medical trailers.

6B. Budget Status Report:

Mr. Hawley reviewed the current budget status report ending September 30, 2019.

6C. Foundation Report:

President Fore and Mr. Wilson have been diligent in soliciting funds for the Foundation's Century Club campaign.

<u>6D. President's Cabinet Reports:</u>

- Dr. Batten announced the collaboration with Academic Affairs in promotion of new student development advising model. We are working for changes in advisement to help students get to the finish line.
- Mr. Dove announced the Student Help Desk initiative is moving along. Working with Computer Technology to create internships.
- Mr. Hawley's report stands as written with no additional comments.
- Ms. Heafner announced we're in our second semester of our EPIC initiative. We've received lots of feedback from our students.
- Ms. Hyman announced the college received significant coverage during Hurricane Dorian. We also received a great amount of coverage on the Grand Opening of the Georgetown Center for Advanced Manufacturing.
- Mr. Mitchell announced the Workforce Development and Continuing Education
 Department working along with Coast RTA to add a bus route from Andrews to the
 Georgetown Campus.
- Ms. Roper reported the Marketing Department is now focusing on student successes. The
 department has purchased a drone and the web services coordinator is Drone certified.
 Also she shared the department is moving forward with the unveiling of the college's new
 mascot in mid-November.
