#### **Enrollment Comparison Update:**

Vice President Batten reported the current Spring 2022 overall Headcount is 5951, and Overall FTE is 3872.

#### **Budget Status Update:**

Vice President Hawley reported on the current budget status report ending January 31, 2022.

## **Capital Projects and Major Renovations Update:**

President Fore and Mr. Hawley gave updates on renovation projects.

## • Conway Campus:

**Lease External Diesel Property from Foundation:** The College must have a long-term lease or own the space for the Diesel property in order to begin renovation. The lease, required to be approved by the State Tech Board, is scheduled for their review on January 25, 2022. Once approved the lease will be finalized with the HGTC Foundation so that renovations can go forth.

**Acquire External Property:** This is an A-1 project to acquire approximately 13,700 square feet of space to support relocating and expanding the Diesel Engine Technician Training Program.

**Upfit and Renovate New Diesel Project:** The project only requires State Tech Board approval which was received on November 16, 2021. Renovations are to be complete by June 30, 2022. Prior to renovating the property, HGTC must lease the property from the Foundation and that lease requires State Tech Board approval.

## • Grand Strand Campus:

**Campus Landscaping and Irrigation:** This project began in mid-July and should be completed by February 15, 2022.

**Building 1000 (Surgical Technologies and OTA):** The project includes possible renovations and acquisition of equipment to meet program needs and changing accreditation requirements. Project to be complete by August 2022.

**Building 600 (Kitchen):** Project includes renovations to small kitchen. Should be completed by Spring 2022.

## • Georgetown Campus:

**Repaving Selected Roads and Parking**: DRG is the civil engineer designing and providing specifications for bidding and overseeing construction. This project requires Capital Budget Office approvals.

**Replacement of HVAC for Building 100:** DWG was hired as its mechanical engineer to design the system and provide specifications for bidding.

# **SEM Works Project Update:**

Vice President Heafner shared that the College contracted with Dr. Jim Black of SEM Works to conduct research on community and stakeholder perceptions of the college. She stated that she would share the findings at a future meeting.

## **Horry County Bucksport Grant:**

Vice President Heafner reported on a 1.9 million training grant approved by Horry County Government and provided through the American Rescue Plan Act (ARPA). This grant will provide access to job training programs offered at HGTC through the Bucksport community educational program.

## **Crane Operator Program**

The College will be offering the first Certified Crane Operating training course in partnership with Skyview Crane Training and Inspections.

## **COVID-19 Update:**

An update was given by Vice Presidents Batten and Snyder on the increase of Covid cases upon our return to work on January 3, 2022. However, those numbers have decreased in the last week. Executive Vice President Wilbanks reported 60% of classes are now offered face to face and 40% online.

## **Mid-Year Operating Budget:**

Mr. Hawley brought forth for approval the mid-year operating budget. The College projects an annual revenue stream of approximately \$50,253,024 based on actual fall and projected spring enrollment. A budgetary surplus of approximately \$2,000,000 is projected by the College.

#### **President's Report**

President Fore serves on the President's Council Legislative Committee. She reported on the SC Technical College System 2022-2023 legislative priorities that included \$50 million (recurring) for base funding for local colleges, \$60 million (non-recurring) for equipment for high demand job skills training, \$160 million (non-recurring) for college maintenance, repair and renovation projects, \$2 million (non-recurring) for continued funding for readySC to deliver on commitments made by the State, \$51.1 million for lottery tuition assistance (LTAP), \$16 million for continued workforce grants for short-term, high demand job skills training, and \$17 million for continued SC WINS Scholarship Program funding.

President Fore reported on the FY2022-23 Funding Request. We are seeking \$10 million in State Funding with a local match of \$5 million. The funding will allow the expansion of our Grand Strand healthcare campus.

President Fore reported Outboard Marine Technology was nominated as a finalist for the national Bellwether Award presented by the Bellwether College Consortium.

Dedication for the Grand Strand Campus is scheduled for Friday, April 22, 2022 at 10:00 a.m.

## **Foundation Report**

Mr. Freeman reported the Annual Foundation Black Tie Gala is scheduled for April 2, 2022. The Foundation Board will begin advertising for the position of President and CEO of the Foundation due to the retirement of Neyle Wilson in April. Mr. Freeman will be retiring from the Foundation Board in July and Tim Tilley will assume the duties of Chair of the Foundation.
