Budget Status Update:

Vice President Hawley reported on the current budget status report ending March 31, 2025.

President Fore and Vice President Hawley reported on the current capital projects and major renovations.

Conway Campus:

• Marilyn J. Fore Health Professions Training Complex Renovation – Meeting held with architect. RFP for Architectural services in progress.

- Automotive Building Expansion Project was awarded to PMH Croft and contract signed on March 17, 2025.
- Cosmetology Labs Renovation/Expansion Completion expected to be late Spring or early Summer 2025.

Grand Strand Campus:

- Repair/Replace Roofing Project to be completed by April 2025.
- Nursing and Health Sciences Institute Move in will occur throughout the month of May. Proposed tentative date for Grand Opening on June 19, 2025. Parking should be completed by June 2025.

Georgetown Campus:

Enrollment Comparison Update:

Vice President Batten reported the current summer 2025 Overall Headcount is 2923 and Overall FTE is 1529. HGTC had the highest percentage increase from the previous year among the 16 technical colleges.

Commencement Update:

Vice President Batten provided an update regarding the upcoming Commencement Ceremony, which is scheduled to take place on Tuesday, May 13, 2025, at the HTC Center on the campus of Coastal Carolina University. The event will feature two ceremonies based on academic majors, the first beginning at 11:00 a.m. and the second at 3:00 p.m. During the ceremonies, we will present the Distinguished Patron Awards to Brent Groome and Tim Tilley, the Student of the Year Award, the Professor of the Year Award, and the Staff of the Year Award. Lunch will be provided in between the ceremonies.

President Fore announced that Horry-Georgetown Technical College has been selected by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) to have its Fifth-Year Interim Report showcased in the Resource Room at the SACSCOC Annual Meeting this December, as well as at each annual meeting through 2027. She also shared that the Associate Degree Nursing (ADN) program achieved a strong start to the year, with students earning a 100% pass rate on the NCLEX exam. In addition, Dr. Fore hosted a luncheon with Mr. Cliff Jones, the newly appointed Superintendent of Horry County Schools.

Foundation Report

Ms. Detzler reported that the Foundation's 17th Annual Black-Tie Gala, held on March 8, 2025, was a resounding success, raising over \$116,000 in support of student scholarships and college initiatives. The elegant evening brought together community leaders, donors, and supporters to celebrate the college's mission and highlight the transformative impact of philanthropy on student success.
