# I. SCOPE OF SOLICITATION

# ACQUIRE SERVICES (JAN 2006)

It is the intent of the State Fiscal Accountability Authority (SFAA) to solicit proposals to provide Comprehensive salaried and hourly payroll banking services to the college on behalf of Horry-Georgetown Technical College in accordance with all requirements stated herein.

# MAXIMUM CONTRACT PERIOD - ESTIMATED (JAN 2006)

Start date: 12/29/2023 End date: 12/28/2028. Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract - Effective Date/Initial Contract Period". [01-1040-1]

This is a one (1) year initial contract term, with four (4), one (1) year option to renew terms. Maximum contract period is five (5) years.

# **II. INSTRUCTIONS TO OFFERORS - A. GENERAL INSTRUCTIONS**

# **DEFINITIONS, CAPITALIZATION, AND HEADINGS (DEC 2015)**

AMENDMENT means a document issued to supplement the original solicitation document.

AUTHORITY means the State Fiscal Accountability Authority or its successor in interest.

BUSINESS means any corporation, partnership, individual, sole proprietorship, joint stock company, joint venture, or any other legal entity. [11-35-310(3)]

CHANGE ORDER means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement of the parties to the contract. [11-35-310(4)]

CONTRACT See clause entitled Contract Documents & Order of Precedence.

CONTRACT MODIFICATION means a written order signed by the procurement officer, directing the contractor to make changes which the clause of the contract titled "Changes," if included herein, authorizes the Procurement Officer to order without the consent of the contractor. [11-35-310(9)]

CONTRACTOR means the Offeror receiving an award as a result of this solicitation.

PAGE TWO means the second page of the original solicitation, which is labeled Page Two.

# **III. SCOPE OF WORK/SPECIFICATIONS**

Horry-Georgetown Technical College (HGTC) is soliciting proposals from qualified full-service FDIC insured banking institutions to provide comprehensive salaried and hourly payroll banking services to the college. The bank should have a branch within a ten (10) mile radius of the Horry-Georgetown Technical College Conway campus, and ideally should have additional locations near the College's other campuses.

Horry-Georgetown Technical College operates two (2) campuses in Horry County and one campus in Georgetown County. The Conway Campus serves as the primary or main campus and is located at:

The College is governed by the Horry-Georgetown Technical College Area Commission.

The college has approximately 625 employees consisting of faculty, staff and student workers and are paid monthly. Approximately ten (10) employees are paid through a check and the remainder are through direct deposit.

#### SCOPE OF WORK

#### 2.1 Depository Related Services

Bank will act as a depository bank for the College and perform all required depository-related services as they relate to receipt and disbursement of funds. All such services subscribed to shall be specified on the "Administrative Cost Schedule" (ACS) referenced herein.

Accounts shall be maintained in the name of the College, or as otherwise directed or permitted by the College, with such additional designations as directed by the College for all banking, finance, accounting, reporting, and legal purposes. Accounts shall include at a minimum a payroll account that can support both the salaried and hourly payroll needs of the college. For FDIC and other legal purposes, the official custodian for the accounts shall be the College's Vice President of Finance and Administration, as specified per § 2.6 of this Agreement.

#### 2.2 Treasury and Business-Related Services

#### (a) Electronic Funds Transfer

Bank shall provide electronic funds transfer (EFT) services including the initiation of wire transfers and the origination of automated clearing house (ACH) entries. All EFT transactions shall be in accordance with applicable law, federal regulations, and National Automated Clearinghouse Association and other applicable banking industry rules and regulations.

#### (b) Fraud Protection

Bank shall make available fraud protection services including Check Positive Pay, ACH Blocks, and ACH Filters. With respect to such fraud protection services, the College may avail itself of the most generous deadlines available under law and in accordance with Bank's procedures and deadlines customarily established for its commercial customers to notify Bank of errors of fraudulent or unauthorized transactions.

#### (c) Investment Services

Bank shall provide an automatic investment service to invest available funds on an overnight basis. Acceptable investments shall include: (i) repurchase agreements fully collateralized with direct obligations of the US Government or one of its agencies, under which the appropriate "Custodian Undertaking Agreement" has been executed; or (ii) sweep to an interest-bearing bank account designed for governments, and which is subject to being secured in accordance with § 2.3 of this Agreement.

#### (d) Reports and Online Services

Bank shall make available to the College reports necessary to facilitate monitoring, reconciliation, financial reporting, external audit, and research requirements. Such reports may be in paper or electronic form and in accordance with agreed upon time frames as established by the College. Bank must offer in-house online banking services that meet the needs

of the institution. Online services shall include but not limited to: Deposits, Withdrawals, Reconciliations, Reporting, Account/Check Look-Up, Electronic Fund Transfers and Same Day Adjustments. The Bank shall provide online services to view and/or receive reports, and to enable the College with the ability to initiate certain transactions, as may be authorized by the College. With respect to errors, discrepancies, fraudulent and unauthorized transactions detected related to reports and online services, the College shall notify the bank using the most generous deadlines available under law and in accordance with Bank's procedures and deadlines customarily established for its commercial customers.

#### 2.3 <u>Security of Deposits</u>

All deposits maintained with Bank must be secured in accordance with the South Carolina Code of Laws, including but not limited to Section 11-1-50. The surety shall be in accordance with the Federal Deposit Insurance Act for allowable amounts for a public unit. Beyond Federal Deposit Insurance Corporation (FDIC) insurance coverage, the surety shall be in accordance with separate security agreements entered into among the College, Bank, and a custody agent, including any qualified financial contracts recognized by the FDIC, any agreements executed pursuant to Operating Circular 7 of the Federal Reserve Bank, any Letters of Credits, and any Indemnity Bonds issued by an authorized surety company. Upon the deposit of funds under this Agreement, Bank shall provide the appropriate surety to protect the deposits in accordance with the applicable method of surety selected and applicable amounts specified by the agreements.

Pursuant to any separate qualified financial contracts with third-party custody agents, or any agreements executed under Operating Circular 7 of the Federal Reserve Bank, if Bank elects to pledge collateral in lieu of obtaining a letter of credit or provide a surety bond to satisfy its obligations under subsection (a) above, Bank must grant the College a security interest in the collateral in accordance with South Carolina's Uniform Commercial Code, other applicable law, and applicable FDIC Policy Statements.

# 2.4 <u>Additional Services</u>

The description of services in this Agreement is not meant to preclude the use of additional services or technologies that may be offered by Bank. Additional optional services may include Remote Deposit service, bank-provided account reconciliation service, international wires, etc.

# 2.5 <u>Additional Work</u>

No additional supplies, work, or services shall be performed or furnished by Bank that are not specifically provided for in this Agreement unless expressly authorized in writing by the College, as provided in § 2.6 of this Agreement.

#### 2.6 Additional Bank Agreements

In addition to this Agreement, the College and Bank may enter into other banking agreements regarding the provision of Bank's treasury, investment and depository related services which include the related addenda and specifically incorporated documents to the Agreement, as well as any subsequent amendments to the Agreement, addenda, and incorporated documents ("Additional Agreements"). The parties agree that Bank's documentation for a particular service(s) subscribed to constitute Additional Agreements for purposes of this Agreement. The entire and integrated agreement between the College and Bank related to the services above shall consist of this Agreement and any Additional Agreements. In the event of conflict or difference among any of the preceding documents, such documents shall govern in the following order of precedence: (1) this Agreement and (2) Additional Agreements in such order of priority as specific in each individual agreement but none superseding this Agreement. Further, in the event the College and Bank execute any other agreements for the provision of banking services, the terms of this Agreement shall control over any conflicting terms in those agreements.

#### 2.7 <u>Authorized Representatives</u>

Bank understands and acknowledges that only the individuals named on the Corporate Resolution may approve actions directed or requested to be taken on behalf of the College. The College may change the persons previously designated as Authorized Representatives and/or the extent of their authority at any time by delivering an updated Corporate Resolution naming the new individual(s) and providing a specimen signature for each. Bank shall be entitled to rely on the Corporate Resolution.

For each account which representatives of the College will be initiating transactions or subscribing to services referenced herein, the College will provide the Bank a signature card designating the individuals authorized to initiate transactions against the account or to subscribe to such services. For accounts which the representatives of the College will have access to the Bank's online system, the College will designate an individual(s) who will serve as the system's security

administrator(s). The security administrator(s) will establish users for the Bank's online system and designate the individuals' respective user roles and entitlements.

# 3.1 <u>Fees</u>

Bank shall be compensated for banking services in accordance with the "Administrative Cost Schedule" contained herein. The College agrees to fees for services per the unit prices listed on the schedule (including any fee for services approved as part of Additional Bank agreements as provided in § 2.6 of this Agreement). The fee schedule may only be amended as mutually agreed upon in writing signed by both Parties.

# 3.2 <u>Method of Payment</u>

The College may compensate Bank by maintaining compensating balances, by direct payment, or by a combination of the two methods. The College will inform Bank of any changes in the compensation method. The College and Bank agree to settle all amounts owed to the Bank or accrued to the College each calendar year by October 31<sup>st</sup> of the following year.

#### 3.3 <u>Compensating Balance Accounts</u>

All payroll accounts which the College maintains with the Bank, unless otherwise authorized to be excluded for a particular purpose, shall accrue monthly earnings credits on the collected balances. Earnings credits accruing on these accounts will offset fees levied during a particular month, or be applied to any deficit earnings credits accruing year-to-date, since the agreed upon annual settlement date. The Bank shall provide for a monthly analysis statement that denotes at least the following elements: the fees levied for the month; the balances available during the month for earnings credits; the month's earnings credit rate (ECR); the excess or deficit earnings credit for the month; the excess or deficit earnings credits for the year-to-date.

# 3.4 Earnings Credit Rate

The earnings credit rate (ECR) referenced in Section 3.3 above is variable and shall be determined at the beginning of each calendar quarter as mutually agreed upon, taking into account the current interest rate environment. In the event a mutual agreement cannot be reached, the College may terminate the Agreement on 90 days' written notice.

# **VII. TERMS AND CONDITIONS -- A. GENERAL**

# ASSIGNMENT, NOVATION, AND CHANGE OF NAME, IDENTITY, OR STRUCTURE (FEB 2015)

(a) Contractor shall not assign this contract, or its rights, obligations, or any other interest arising from this contract, or delegate any of its performance obligations, without the express written consent of the responsible procurement officer. The foregoing restriction does not apply to a transfer that occurs by operation of law (e.g., bankruptcy; corporate reorganizations and consolidations, but not including partial asset sales). # NOTICE (JAN 2006)

(A) After award, any notices shall be in writing and shall be deemed duly given (1) upon actual delivery, if delivery is by hand, (2) upon receipt by the transmitting party of automated confirmation or answer back from the recipient's device if delivery is by telex, telegram, facsimile, or electronic mail, or (3) upon deposit into the United States mail, if postage is prepaid, a return receipt is requested, and either registered or certified mail is used. (B) Notice to contractor shall be to the address identified as the Notice Address on Page Two. Notice to the state shall be to the Procurement Officer's address on the Cover Page. Either party may designate a different address for notice by giving notice in accordance with this paragraph. [07-7A050-1]

#### **OPEN TRADE (JUN 2015)**

# PAYMENT and INTEREST (FEB 2021)

(a) The State shall pay the Contractor, after the submission of proper invoices or vouchers, the prices stipulated in this contract for supplies delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified herein, including the purchase order, payment shall not be made on partial deliveries accepted by the Government.

(b) Unless otherwise provided herein, including the purchase order, payment will be made by electronic funds transfer (EFT). See clause titled " EFT Information."

(c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, the State shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to the State shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. Section 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The State shall have all of its common law, equitable and statutory rights of set-off. [07-7A055-4]

#### PUBLICITY (JAN 2006)

Contractor shall not publish any comments or quotes by State employees or include the State in either news releases or a published list of customers, without the prior written approval of the Procurement Officer. [07-7A060-1]

#### PURCHASE ORDERS (JAN 2006)

Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. [07-7A065-1]

# SURVIVAL OF OBLIGATIONS (JAN 2006)

The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. [07-7A075-1]

# **TAXES (JAN 2006)**

Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by the State, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by the State. It shall be solely the State's obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. Contractor agrees to refund any tax collected, which is subsequently determined not to be proper and for which a refund has been paid to contractor by the taxing authority. #### WAIVER (JAN 2006)

The State does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Officer has actual authority to waive any of the State's rights under this Contract. Any waiver must be in writing. [07-7A095-1]

# **VII. TERMS AND CONDITIONS -- B. SPECIAL**

# CHANGES (JAN 2006)

(1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

(a) drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the [State] in accordance therewith;

(b) method of shipment or packing;

(c) place of delivery;

(d) description of services to be performed;

(e) time of performance (i.e., hours of the day, days of the week, etc.); or,

(f) place of performance of the services. Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.

(2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the State promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.

(3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the State is prejudiced by the delay in notification.

(4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract. [07-7B025-1]

# COMPLIANCE WITH LAWS (JAN 2006)

During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs. [07-7B035-1]

#### CONFERENCE -- PRE-PERFORMANCE (JAN 2006)

Unless waived by the Procurement Officer, a pre-performance conference between the contractor, state and Procurement Officer shall be held at a location selected by the state within five (5) days after final award, and prior to commencement of work under the contract. The responsibilities of all parties involved will be discussed to assure a meeting of the minds of all concerned. The successful contractor or his duly authorized representative shall be required to attend at contractor's expense. [07-7B040-1]

#### **CONTRACTOR PERSONNEL (JAN 2006)**

The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

# **CONTRACTOR'S OBLIGATION -- GENERAL (JAN 2006)**

The contractor shall provide and pay for all materials, tools, equipment, labor, and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements. [07-7B065-1]

# DEFAULT (JAN 2006)

(a) (1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to:

(i) Deliver the supplies or to perform the services within the time specified in this contract or any extension;

(ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or

(iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause).

(2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure.

(b) If the State terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.

(c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.

(d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.

(e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest.

(f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders.

(g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State be adjusted to

compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.

(h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract.

# PRICE ADJUSTMENTS (JAN 2006)

(1) Method of Adjustment. (a) by agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;

(b) by unit prices specified in the Contract or subsequently agreed upon;

(c) by the costs attributable to the event or situation covered by the relevant clause, including profit if otherwise allowed all as specified in the Contract; or subsequently agreed upon;

(d) in such other manner as the parties may mutually agree; or,

(e) in the absence of agreement by the parties, through a unilateral initial written determination by the Procurement Officer of the costs attributable to the event or situation covered by the clause, including profit if otherwise allowed all as computed by the Procurement Officer in accordance with generally accepted accounting principles, subject to the provisions of Title 11, Chapter 35, Article 17 of the S.C. Code of Laws.

(2) Submission of Price or Cost Data. Upon request of the Procurement Officer, the contractor shall provide reasonably available factual information to substantiate that the price or cost offered, for any price adjustments is reasonable, consistent with the provisions of Section 11-35-1830.

# **RELATIONSHIP OF THE PARTIES (JAN 2006)**

# TERM OF CONTRACT -- EFFECTIVE DATE / INITIAL CONTRACT PERIOD (JAN 2006)

The effective date of this contract is the first day of the Maximum Contract Period as specified on the final statement of award. The initial term of this agreement is 1 years, 0 months, 0 days from the effective date. Regardless, this contract expires no later than the last date stated on the final statement of award. [07-7B240-1]

# TERM OF CONTRACT -- OPTION TO RENEW (FEB 2021)

At the end of the initial term, and at the end of each renewal term, this contract shall automatically renew for a period of 1year(s), month(s), and day(s), unless contractor receives notice that the state elects not to renew the contract at least thirty (30) days prior to the date of renewal. Regardless, this contract expires no later than the last date stated on the final statement of award. [07-7B245-3]

# **TERMINATION FOR CONVENIENCE (JAN 2006)**

(1) Termination. The Procurement Officer may terminate this contract in whole or in part, for the convenience of the State. The Procurement Officer shall give written notice of the termination to the contractor specifying the part of the contract terminated and when termination becomes effective.

(2) Contractor's Obligations. The contractor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination the contractor will stop work to the extent specified. The contractor shall also terminate outstanding orders and subcontracts as they relate to the terminated work. The contractor shall settle the liabilities and claims arising out of the termination of subcontracts and orders connected with the terminated work. The Procurement Officer may direct the contractor to assign the contractor's right, title, and interest under terminated orders or subcontracts to the State. The contractor must still complete the work not terminated by the notice of termination and may incur obligations as are necessary to do so.

(3) Right to Supplies. The Procurement Officer may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the Procurement Officer: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called "manufacturing material") as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. The contractor shall, upon direction of the Procurement Officer, protect and preserve property in the possession of the contractor in which the State has an interest. If the Procurement Officer does not exercise this right, the contractor shall use best efforts to sell such supplies and manufacturing materials in a accordance with the standards of

Uniform Commercial Code Section 2-706. Utilization of this Section in no way implies that the State has breached the contract by exercise of the Termination for Convenience Clause.

(4) Compensation. (a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph.

(b) The Procurement Officer and the contractor may agree to a settlement and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the State, the proceeds of any sales of supplies and manufacturing materials under Paragraph (3) of this clause, and the contract price of the work not terminated;

(c) Absent complete agreement under Subparagraph (b) of this Paragraph, the Procurement Officer shall pay the contractor the following amounts, provided payments agreed to under Subparagraph (b) shall not duplicate payments under this Subparagraph:

(i) contract prices for supplies or services accepted under the contract;

(ii) costs reasonably incurred in performing the terminated portion of the work less amounts paid or to be paid for accepted supplies or services;

(iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph; (iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated.

(d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles.

(5) Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the State's right to require the termination of a subcontract, or (ii) increase the obligation of the State beyond what it would have been if the subcontract had contained an appropriate clause.

# ATTACHMENT A

# IMPORTANT TAX NOTICE - NONRESIDENTS ONLY

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C. Department of Revenue or the S.C. Secretary of State and (b) submits a Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to the person letting the contract.

The withholding requirement applies to every governmental entity that uses a contract ("Using Entity"). Nonresidents should submit a separate copy of the Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to every Using Entity that makes payment to the nonresident pursuant to this solicitation. Once submitted, an affidavit is valid for all contracts between the nonresident and the Using Entity, unless the Using Entity receives notice from the Department of Revenue that the exemption from withholding has been revoked.

Section 12-8-540 requires persons making payment to a nonresident taxpayer of rentals or royalties at a rate of \$1,200.00 or more a year for the use of or for the privilege of using property in South Carolina to withhold 7% of the total of each payment made to a nonresident taxpayer who is not a corporation and 5% if the payment is made to a corporation. Contact the Department of Revenue for any applicable exceptions.

#### ATTACHMENT B

#### **OFFEROR'S CHECKLIST -- AVOID COMMON BID/PROPOSAL MISTAKES**

Review this checklist prior to submitting your bid/proposal.

If you fail to follow this checklist, you risk having your bid/proposal rejected.

- Do not include any of your standard contract forms!

- Unless expressly required, do not include any additional boilerplate contract clauses.

- Reread your entire bid/proposal to make sure your bid/proposal does not take exception to any of the state's mandatory requirements.

- Make sure you have properly marked all protected, confidential, or trade secret information in accordance with the instructions entitled: SUBMITTING CONFIDENTIAL INFORMATION. <u>DO NOT</u> mark your entire bid/proposal as confidential, trade secret, or protected! <u>Do not</u> include a legend on the cover stating that your entire response is not to be released!

- Have you properly acknowledged all amendments? Instructions regarding how to acknowledge an amendment should appear in all amendments issued.

- Make sure your bid/proposal includes a copy of the solicitation cover page. Make sure the cover page is signed by a person that is authorized to contractually bind your business.

- Make sure your Bid/proposal includes the number of copies requested.

- Check to ensure your Bid/proposal includes everything requested!

- If you have concerns about the solicitation, do not raise those concerns in your response! After opening, it is too late! If this solicitation includes a pre-bid/proposal conference or a question & answer period, raise your questions as a part of that process! Please see instructions under the heading "submission of questions" and any provisions regarding pre-bid/proposal conferences.
