- The awarded contractor will be provided with the mailing list.
- The awarded contractor's mailing system shall have the ability to contain Palletization and the pallets to be labeled per post office requirements.
- The awarded contractor will be required to deliver the printed and addressed mailers to the appropriate SCF in South Carolina to save the most postage (Carrier Route rates as available) once the appropriate approvals and acceptances have been issued from the Conway Post Office (29526) where Horry-Georgetown Technical College's permit is held.
- Printing and mailing services must occur on location of the awarded contractor.
