## **Budget Status Update:**

Vice President Hawley reported on the current budget status report ending July 31, 2022.

### **Capital Projects and Major Renovations Update:**

President Fore and Vice President Hawley gave the report on current capital projects and major renovations.

## • Conway Campus

**Upfit and Renovate New Diesel Property:** Renovations have begun, and all work should be complete by September 5, 2022.

**HVAC Upgrades for Building 1100:** The College hired DWG as its mechanical engineer to design the system and provide specifications for bidding. We submitted an A-1 Project on April 8, 2022 to change the source of funds to State Appropriated Deferred Maintenance and the project approved by the Capital Budget Office on May 27. Construction should be complete January-May 2023.

**Building 1000 Elevator Renovation:** The project is to renovate the elevator system in Building 1000. This is an A-1 project due to the source of funds being state appropriated deferred maintenance.

## Grand Strand Campus

**Building 100 Renovation and Expansion:** This is an A-1 capital project dedicated to expanding the College's Nursing and Health Science programs. The Phase 1 package submitted to Columbia on July 7, 2022 and scheduled to receive approval from the State Fiscal Accountability Authority (SFAA) on August 30, 2022.

**Building 1000 OTA Renovations and Equipment:** This project includes renovations and acquisition of equipment to meet new program needs and accreditation requirements. The project, budgeted at \$100,000, should be complete by August 2022.

## • Georgetown Campus

**Replace HVAC for Building 100:** Construction should be complete January-May 2023.

**Building 100 Elevator Renovation:** The project is to renovate the elevator system in Building 100. This is an A-1 project due to the source of funds being state appropriated deferred maintenance.

### **Enrollment Comparison Update:**

Dr. Batten reported the current overall fall Headcount is 7145, a 25% increase compared to fall 2021. The overall FTE is 4764. Second among the South Carolina technical colleges.

#### **Action**

#### **Tuition Increase to State Minimum:**

Mr. Hawley brought forth for approval a request for a spring 2023 tuition increase. He reported the tuition increase is necessary for the College to remain at the 2022-23 minimum tuition level as revised and approved by the State Board. HGTC has the lowest tuition in the State. Motion by Mr. Hucks, seconded by Mr. Cohens and carried that the Area Commission approves a spring 2023 tuition increase of 2.7% as allowed by HEPI and as recommended by the State Board. For in-state students, the tuition cost per credit hour will increase by \$4.00 from \$171 per credit hour to \$175.

## **Differential Tuition Program:**

Mr. Hawley presented for approval a request to implement a differential tuition. Differential tuition is the practice of changing a different tuition rate by individual course, program, school, or college. Mr. Hawley gave an overview of the proposed in-county rates per credit hour as well as other fees charged to all students. Motion by Mr. Hucks, seconded by Dr. Farrar and carried that the Area Commission approves the implementation of a differential tuition as presented beginning in fall 2023.

President Fore will be meeting with Patrick Sparks from Sparks Toyota, and twelve automobile dealers to discuss the implementation of an automotive technician program. The South Carolina Automobile Dealers Association (SCADA) wants to provide scholarships to students.

NEW for Fall 2022, the HGTC/CCU Teacher Education partnership has been designated a SC CREATE Center. SC CREATE allows *full-time employees* in SC public and charter schools to receive cost-free course work to complete add-on, alternative, or initial licensure in special education and various related services personnel areas. The HGTC/CCU Center allows qualified recipients to earn their AAS in Teacher Education and their Bachelor of Arts in Special Education fully distanced and online. The grant award for 2022-23 is \$362,669.

The Surgical Technology students awarded 2<sup>nd</sup> place national honors in the AST National Scrub Bowl Championship at the national conference held in New Orleans, Louisiana.

The Culinary Arts students received 2<sup>nd</sup> Place overall at the American Culinary Federation Student Team of the Year Competition in Las Vegas, Nevada during the 2022 ACF National Convention.

President Fore attended the South Carolina Commission on Higher Education Annual Board Retreat as the Chair of the Council of Presidents. She shared a list of goals the Commission plans to accomplish by July 1, 2023.

President Fore briefly discussed a draft of the South Carolina Technical College System FY2023-24 legislative agenda. The agenda has not yet been adopted by the President's Council.

President Fore and Executive Vice President Wilbanks continue to meet with leadership of Tidelands Health to discuss health care partnerships and facilities/shared space.

Dr. Fore announced Greg Mitchell will be serving the College in a new roll upon his recent retirement. He will serve as Community Liaison.

- Ms. Hyman reported on current media coverage. Total media exposure was 256 hits, including news media and social media mentions. The potential reach was 110 million people. The monetary value of media coverage was \$1.02 million.
